### **PAYMENT OF ENROUTE NAVIGATION CHARGE BY ALL FOREIGN NON IATA CHARTER OPERATORS OVERFLYING THE BOTSWANA AIRSPACE**

All foreign non-IATA scheduled and non-scheduled operators intending to overfly the Botswana airspace are hereby informed that they are required to apply for permits to operate in the Botswana airspace and make payment for Enroute Navigation Charge before the flight takes place.

There is a form available on the CAAB website that you can use to apply for the permit. There is also a calculator on the website that will calculate the total amount the operator is expected to pay once you input the route for the intended flight.
