Statutory Instrument No. 103 of 2021, published on the 3rd of December 2021.

3. Civil Aviation (Aeronautical Radio Frequency Spectrum Utilisation) Regulations

Statutory Instrument No. 44 of 2022, published on the 29th of April 2022.
